## IAPM Elections 2014

Nominations are invited by the Honorary Secretary for the election to the following posts to be elected through postal/electronic ballot.

1. **President (one post)**, tenure of one year
2. **Vice President (one post)** , tenure of one year

The duties of the above posts are provided in the Bye-Laws of the Association. Every candidate for the post of President and Vice President should have at least 10 years standing as Life Member (without interruptions) and have served the Association in one or more ways by being an office-bearer, or being a member of the council or Chapter/Chairperson or participating in Symposium/Seminar at the Annual Conference or as an Organizing Secretary/Chairman.

Nominations are to be made on plain paper duly proposed and seconded by Members who do not owe any membership dues (such as Life Members). The nominated member, proposer and seconder should provide their IAPM Membership Numbers and sign the nomination. The nominated candidate shall provide a letter of consent and a copy of their bio-data (not exceeding one A4 size page)

Last date for receipt of nominations is **31<sup>st</sup> August 2014**. Last date for withdrawal of nominations is **25<sup>th</sup> September 2014**. Ballot Papers will be dispatched by **30<sup>th</sup> September 2014**. Ballot papers will be dispatched only to those members who have cleared all dues by 30<sup>th</sup> June 2014 as notified by the Honorary Treasurer. If possible, electronic ballot will be introduced. Last date for **receipt of Ballot papers** is 15<sup>th</sup> **November 2014**.

The Association shall not be responsible for any delays/non-receipt of ballot papers due to incorrect address/postal delays or similar circumstances beyond its control.

Note: Under no circumstances the candidates should canvas for elections by any means.

## IAPM Announcements 2014

1. **IAPM Awards Session:** Applications from IAPM members are invited for the Dr VR Khanolkar Prize, Smt. Kunti Devi Mehrotra Award, Prof KC Basu Mallick Award, and Best Paper. The applications, complete in all respects should reach the Honorary Secretary by the **31<sup>st</sup> August 2014**.

a) **Dr V R Khanolkar Prize:** The Dr VR Khanolkar Prize is one of the most prestigious awards of IAPM for published research work. The contest for this prize is open to all members fulfilling the following criteria:

- The contest is open to those below 45 years of age on 31<sup>st</sup> July 2014 (age proof to be provided)
- The research work submitted should have been carried out in India
- The above research work should have been published in the preceding two years

The principal author shall submit a Covering letter indicating the IAPM Membership number, Certificate from **all authors** certifying that this research work has been carried out in India and this work has not received any other award, along with Certificate from the **co-authors** (if any), attesting and supporting the candidature of the principal author. In case the applicant is a postgraduate or senior resident, there should be letter from Head of the Department/Dean stating that the applicant is eligible for the award. Pdf format of the published paper is to be submitted to the Secretary IAPM with the biodata of the applicant.

The publication will be judged by a panel of three judges to be appointed by the President/Honorary Secretary, IAPM. The award may be shared by more than one paper if so adjudged or no prize may be given if no entry is found suitable. The prize carries a certificate that will be distributed during APCON 2015.

### b) **Smt Kunti Devi Mehrotra Award**

The Smt Kunti Devi Mehrotra Award is another prestigious award given annually for published research work. The award is open to all members fulfilling the following criteria:

- The applicant should be below 50 years of age on 31<sup>st</sup> July 2014 (age proof to be provided)
- The research work submitted should have been carried out in India
- The above research work should have been published by the contesting member as the first author in the preceding two years

The principal author shall submit a Covering letter indicating the IAPM Membership number, Certificate from **all authors** certifying that this research work has been carried out in India and this work has not received any other award, along with Certificate from the **co-authors** (if any), attesting and supporting the candidature of the principal author.

The publication will be judged by a panel of three judges, one nominated by the family of Smt. Mehrotra and two by the President/Honorary Secretary, IAPM. The award may be shared by more than one paper if so adjudged or no prize may be given if no entry is found suitable.

**c) Prof KC Basu Mallick Award**

This award is given to the best paper presented during the plenary session of the Annual Conference of IAPM. The award is open to all members fulfilling the following criteria:

- There is no age restriction,
- The research work should have been carried out in India

The Principal author shall submit a statement from his/her co-authors (if any) supporting his/her candidature for the award. All candidates should submit a full-length text of the research work to be presented in the form of a manuscript for publication for the Indian Journal of Pathology and Microbiology. The paper shall be scrutinized by a panel of referees selected by the President/Secretary IAPM and a maximum of five papers will be selected for presentation. The time allotted for presentation is generally 10 minutes only. The judges for the Plenary Session shall be appointed by the President/Honorary Secretary maintaining strict confidentiality. If none of the presentations are found suitable no award may be given. Certificate will be distributed during APCON 2015.

**d) Best Paper Award**

This award is given to the best paper presented during the plenary session of the Annual Conference of IAPM. The rules are similar to the Prof KC Basu Mallick Award except:

- Age below 35 years on 31<sup>st</sup> December 2013 (age proof to be provided)
- A maximum of four papers will be selected for presentation

## **5. Free papers and Posters**

a) The presenting authors for the free paper or poster session should be members of IAPM. Only registered delegates can send the abstracts. Each member can present only one paper (either paper or poster and not both).

b) The **First Page** should contain the following details: Name of the Presenting Author, IAPM Number, Address for correspondence, Delegate registration number (if already available), Mobile number, Email, Choice for presentation (whether oral presentation or poster) and the appropriate sub-specialty.

c) If you are a non-member and wish to present paper or poster, then kindly apply for IAPM membership in advance and indicate acknowledgment number provided by the Honorary Treasurer's office in the space provided for 'IAPM membership number'.

d) The delegates may choose the following sub-specialty: Autopsy Pathology, Bones/Joints/Soft Tissue Pathology, Cytopathology, Dermatopathology, Endocrine Pathology, Gastrointestinal Pathology, Hepatobiliary & Pancreatic Pathology, Laboratory Medicine (includes Biochemistry, Clinical Pathology, Immunology and Hematology), Lymphoreticular Pathology, Microbiology, Neuropathology, Pediatric Pathology, Thoracic Pathology, Uro-genital & Breast Pathology, **AND** Others.

e) The abstract should be provided in the second page. It should include: the **Title, Authors' names** (presenting author's name should be underlined), and **Institutional Affiliations**. The abstract is restricted to a maximum of 250 words.

f) For a free paper, the abstract should include: **Objectives, Methods, Results, Conclusions**, and **Key words**. Please check for grammar and spelling mistakes. The number of cases/patients for a free paper should be more than ten, otherwise it will be relegated to the poster category, unless the cases are unusual or rare.

g) For a poster, the abstract should include: **Objectives, Case Report, Conclusions**, and **Key words**. Those who are presenting posters should bring with them the electronic version of the poster for presentation if selected for the plenary session.

h) All abstracts are peer reviewed, and the IAPM reserves the right to assign it as oral or poster presentation. The abstract therefore should not be casually written and due care should be taken to ensure its contents. No correspondence regarding a change in the presentation shall be entertained and all members are requested not to contact the Conference Secretariat or the Honorary Secretary in the matter.

i) All the abstracts are to be uploaded using online registration at the conference web-site. There is no need to send hard copies by post or by CDs. This is meant for the non-award papers only.

j) The cut-off date will be **30<sup>th</sup> September 2014**. No abstracts will be taken after this deadline. Abstracts may be withdrawn by a written communication via email to the Secretary by **15<sup>th</sup> October 2014**. Accepted abstracts will be listed on the conference web-site by **31<sup>st</sup> October 2014**.
